DECLARATION OF ROBERT J. SCARAMOZZINO – IN RESPONSE TO THE COURT'S REQUEST

Robert J. Scaramozzino declares pursuant to 28 U.S.C. § 1746:

- I am the Executive Assistant to Cecil E. Roberts, President of the United Mine Workers of America ("UMWA" or "Union"), and have held this position since January 2012. Prior to my current position, I served as Administrator of the President's Office for approximately 17 years. Since 1985 I have been employed by the UMWA International Union, and I have been an active member of the UMWA since 1972. In my capacity as the Executive Assistant to the UMWA President, I have been involved in many aspects of the UMWA's activities related to Patriot's bankruptcy action.
- I submit this declaration pursuant to the Court's request concerning the letters
 UMWA members have submitted.
- The facts set forth in this declaration are based on my firsthand knowledge. If called to testify, I would testify competently to the facts set forth in this declaration.
- 4. In the attached memorandum, mailed on or about September 28, 2012, President Roberts advised our members that they could share their personal stories by submitting a respectful letter to the Court. See Attachment 1. We sent this memorandum because the UMWA was being inundated with calls from members about the Patriot bankruptcy. Attorneys from

Kennedy, Jennik & Murray, the Union's outside counsel in this matter, did not draft, review or know about the September 28, 2012 memorandum prior to its distribution. The memorandum was, however, reviewed by the Legal Department of the UMWA prior to its distribution.



RE: Patriot Update and Information Request

I am writing to provide you with an update regarding the Patriot Bankruptcy and to ask that you also provide some specific information. To accomplish our goal, I am going to need your assistance and I can assure you that all of this information is critical in helping to preserve your benefits.

The information and requests are as follows:

- On September 11-12, 2012, the Bankruptcy Judge in New York held a
 hearing on the Change of Venue motion filed by the UMWA and others. At
 the conclusion of the hearing, the Judge asked that all interested parties
 submit briefs on October 5, 2012. We expect the Judge to issue her ruling
 by mid to late October. As soon as she makes her ruling, I will inform you
 of her decision.
- Even if the Judge rules against moving the case to Charleston, West Virginia, where it rightfully belongs, the UMWA will participate in the bankruptcy proceedings whether it is in New York City or St. Louis.

- We will be asking for volunteers, mostly retirees and widows, to attend the
 hearings. We need people who are willing to spend one week at a time at the
 venue location chosen by the Judge. The UMWA will provide
 transportation, lodging and per diem. You may be contacted to participate.
- Every Monday I will be doing a Robocall (Automatic Telephone Message)
 to all members to provide you with an update. Calls will be made at
 approximately 1:00 p.m. and 7:00 p.m. Eastern Time. I was told once the
 Robocalls begin it will take approximately one and one-half hours to reach
 all members.
- Enclosed is an "Information Request Form" that I am asking you to please
 fill out and return to the International Headquarters. For your convenience I
 have enclosed a self-addressed stamped envelope to return the form.
 Because of Indiana's state law regarding automatic calls, a special form has
 been prepared for residents of Indiana.

Returning this form is critical so that we will be able to communicate with you regarding the status of the bankruptcy and your benefits.

 I know that many of you are stricken with some very serious illnesses. It is very important that the Bankruptcy Judge really understands what is at stake and that we put a face on your problem.

I am encouraging members who would like to share your personal story to write the Judge letting her know about your illness and what would happen if you lost your health care. Your personalized story will become part of the permanent public record. I do understand how very angry you are but I ask that any letters be courteous and non-threatening.
