
PANAGIOTA MANATAKIS, being duly sworn, deposes and says:

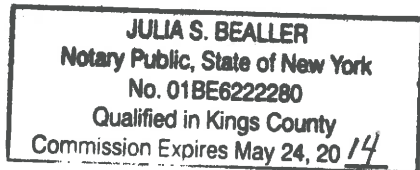
