ORDER GRANTING EMERGENCY MOTION OF THE UNITED MINE WORKERS OF AMERICA 1974 PENSION TRUST AND THE UNITED MINE WORKERS OF AMERICA 1993 BENEFIT PLAN TO EXTEND THE TIME TO RESPOND TO THE DEBTORS' MOTION FOR AUTHORITY TO IMPLEMENT COMPENSATION PLANS

Upon the Emergency Motion (the "Motion") of the United Mine Workers of America 1974 Pension Trust and the United Mine Workers of America 1993 Benefit Plan, filed with this Court on February 15, 2014 [ECF No. 2854], to Extend the Time to Respond to the *Debtors' Motion for Authority to Implement Compensation Plans* (the "AIP/CERP Motion"); and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. § 1334 and Rule 81-9.01(B)(1) of the Local Rules of the United States District Court for the Eastern District of Missouri; and consideration of the Motion and the requested relief being a core proceeding the Bankruptcy Court can determine pursuant to 28 U.S.C. § 157(b); and the Court having determined that notice of the Motion was sufficient under the circumstances and that no other or further notice need be provided; and the Court having reviewed the Motion and having held a hearing with appearances of parties in interest noted on the record, and after due deliberation and sufficient cause appearing therefore, it is hereby:

ORDERED that, pursuant to Rule 9006(b) of the Federal Rules of Bankruptcy Procedure and L.R. 9006-B of the Local Rules of the United States Bankruptcy Court for the Eastern District of Missouri, the Motion is granted as set forth herein; and it is further

ORDERED, that the deadline for all parties in interest to file responses to the AIP/CERP Motion (collectively, the "Responses") shall be March 8, 2013 at 11:59 p.m. prevailing Central Time; and it is further

ORDERED, that the deadline for the Debtors to file their replies to the foregoing Responses shall be March 15, 2013 at 11:59 p.m. prevailing Central Time; and it is further

ORDERED, that a hearing on the AIP/CERP Motion shall be held before this Court on March 18, 2013 at 1:00 p.m. prevailing Central Time in Courtroom 7-North; and it is further

ORDERED, that the parties shall meet and confer to discuss any discovery disputes arising in connection with the AIP/CERP Motion, and, in the absence of an agreement among the parties as to any such dispute, this Court shall hear and determine such dispute.

No later than 7 days after the date of this order, the United Mine Workers of America 1974 Pension Trust and the United Mine Workers of America 1993 Benefit Plan are directed to serve a copy of the order on all parties listed below and are directed to file a certificate of service no later than 24 hours after service.
