DECLARATION OF MICHAEL LUNA IN SUPPORT OF DEBTORS' MOTION FOR AN ORDER AUTHORIZING THE MODIFICATION AND TERMINATION OF CERTAIN NON-VESTED BENEFITS FOR NON-UNION RETIREE BENEFIT PARTICIPANTS PURSUANT TO 11 U.S.C. §§ 105(a) AND 363(b)

- I, Michael Luna, under penalty of perjury, declare as follows:
- 1. I am the Vice President of Human Resources and Employee Services of Patriot Coal Corporation ("Patriot") and have been employed by Patriot since November 21, 2011. In my current position, I am responsible for the administration of the Debtors' global employee and retiree benefits plans and programs.
- 2. I submit this declaration in support of the Motion (the "Motion")<sup>2</sup> of the Debtors for an order authorizing the Debtors to modify the Non-Union Retiree Life Insurance Benefits

and terminate the Non-Union Retiree Medical Benefits, as set forth in the Motion, pursuant to section 363 of the Bankruptcy Code. Except as otherwise noted, the matters set forth herein are based upon my review of relevant documents, information provided to me or verified by employees working under my supervision or the Debtors' professional advisors, including Davis Polk & Wardwell LLP and Bryan Cave LLP, and my experience, knowledge and information concerning the Debtors' benefits plans and programs. If called upon to testify, I would testify competently to the facts set forth in this declaration.

#### **Documentation of the Non-Union Retiree Benefits**

3. The Debtors have conducted a thorough inventory of their employee and retiree benefit plan records in connection with the changes proposed by the Motion. To the best of my knowledge, the Plan Documents listed in Appendix A hereto represent all of the Plan Documents relevant to the Non-Union Retiree Benefits that could be located through a good faith search and due inquiry. True and correct copies of the Plan Documents listed in Appendix A have been or will be provided to the Court, the U.S. Trustee, counsel to the Non-Union Retiree Committee, counsel to the UCC and counsel to the administrative agents for the Debtors' postpetition lenders. In addition, true and correct copies of the Plan Documents listed in Appendix A will be made available at <a href="https://www.patriotcaseinfo.com/exhibits.php">www.patriotcaseinfo.com/exhibits.php</a>.

#### **Previous Unilateral Modifications of the Non-Union Retiree Benefits**

4. Certain of the Debtors have, from time to time in the past, unilaterally modified the Non-Union Retiree Benefits, including by annually increasing the annual premiums paid by Non-Union Retirees under the Patriot Salaried Retiree Medical Benefits for Legacy Peabody Energy Corporation Retirees, Patriot Medical Benefits Plan for Legacy Magnum Retirees, Catastrophic Group Health Plan for Salaried Employees Terminated Through a Reduction in Force and Catastrophic Retiree Medical Plan. Further, in 2010, certain of the Debtors

unilaterally imposed plan design modifications for the Patriot Medical Benefit Plan for Legacy Magnum Retirees and the Patriot Salaried Retiree Medical Benefit Plan for Legacy Peabody Energy Corporation Retirees and reduced the retiree life insurance benefits provided under such plans. Similarly, in 2008, 2009 and 2010, certain of the Debtors changed the eligibility requirements for the Medical Premium Reimbursement Allowance Plan and the Patriot Medical Benefits Plan for Legacy Magnum Retirees.

5. None of the Debtors' unilateral modifications of the Non-Union Retiree Benefits prior to the Petition Date have been challenged or contested.
