(b) **Exhibits:** Exchange an Exhibit List with all parties and file one copy with the Clerk by April 25, 2013 at 8:00 p.m. Central Time. Prepare, mark, and exchange sufficient legible copies of all exhibits to provide two (2) copies for

the Court and all parties listed below by Friday, April 26, 2013 at 12:00 p.m. Central Time.

(c) **Stipulation of Exhibits:** Stipulate as to which exhibits may be introduced without objection or preliminary identification and file all written objections to exhibits by April 25, 2013 at 8:00 p.m. Central Time.

(d) **Deposition Designations:** For deponents for whom a declaration has not been submitted, file designations of deposition testimony by Friday, April 26, 2013 at 8:00 p.m. Central Time.
