IN REGARD TO BRYAN CASE 3/26/14 HE STATES IN PARAGRAPH 2 MR WYCISKALLA APPEARS TO BE CLAIMING THAT HE WILL NOT HAVE INSURANCE COVERAGE AFTER MARCH 31. MY REPLY TO THIS IS I HAVE BEEN DISABLED FOR 26 YEARS AND DEPENDENT ON ARCH OF ILLINOIS INS, MAGNUM COAL INSURANCE - PATRIOT COAL INSURANCE AND
